**Business Plan**

- Metering Station and Natural Gas Transmission System (MPT) SR continues to plan to participate in bidding for other projects related to the natural gas metering and transmission system construction business because the natural gas used in the category of Electric power continues to increase as the country's energy demand continues to increase.
- Engineered Pumps and Systems (EPS) SR has focused on designing and selling industrial pump products under the brand that the company has appointed as a distributor, including products related to the same industry. SR focused on keeping good relationships with an Existing customer base and expanding to new customer groups and expanding the main product market such as Gear Pump, Viking, and ITT to the market of competitors and new customers in potential industries. In addition, SR also focuses on selling equipment and designing Pump Package systems, and upgrading the efficiency of compressor systems to increase sales in the petrochemical industry and refineries, etc.

**Performance and Analysis**

**Business Performance Summary**

The Company generated main revenue of Baht 472.52 million, decreasing by Baht 58.62 million or 11.04% from the same period last year. The significant increase in revenue were from;

- The Metering and Pipeline Transmission Business Unit could not recognize the revenue as per expected decreasing from work progress construction project on hand.
  - Car park service consists of the management of parking building and commercial property for rental and services Business Unit had revenues is not related to costs and expenses incurred in the period.
  - The NGV distribution station, Bangna branch, has been closed due to the expiration of the gas purchase agreement.
  - The Company reported other incomes of Baht 1.28 million, decreased from the same period last year by Baht 1.47 million or 53.45%. In the six-month period ended 30 June 2023, there were increased exchange and in 2024 has other incomes was from reversed provisions for import duties and value added tax of Baht 30.86 million.
- The Company had loss attributable to Owners of the parent of Baht 17.38 million, net loss increasing by Baht 3.43 million or at the rate 24.59%, mainly due to

- The Company had cost and expenses of Baht 449.87 million, and decreasing from the same period last year by Baht 67.92 million or at the rate 13.12 %, from the decrease in variable costs which corresponded with the decrease in main revenues.
- The Metering and Pipeline Transmission Business Unit. There is an increase in project costs from the device has a problem and has not passed the test. Currently waiting to receive products .

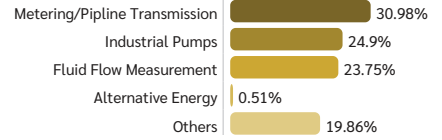
**Risk Management Policy**
